Data and purpose of the processing

below. The data subject of the processing is the navigation data.

1. Navigation Data

The computer systems used to operate the website acquire some data necessary for the operation of the

platform and information whose transmission is implicit in the protocols used for connection and internet

browsing.

Some information relating to the browser session and general data relating to the device used by the user are

also acquired. All data is acquired anonymously and not traceable, however, to a specific user or for profiling

purposes.

2. Data provided voluntarily by the use

after having read the present information and possible consent to the processing for one or more of the

## **Modality of Processing**

The processing of data may consist of its collection, registration, organization, structuring, conservation, adaptation, modification, extraction, consultation, use, communication, comparison or interconnection, limitation, cancellation and destruction, according to what is foreseen by art. 4 n. 2) of the GDPR.

The data will be processed both on paper and electronic and / or automated.

## Communication and data transfer

- External Managers according to art.28 of the GDPR.

For all purposes indicated in this document, your data may also be communicated abroad, inside and outside the European Union, in compliance with the rights and guarantees provided by current legislation.

## **Rights of Interested Parties**

In relation to the aforementioned data, all rights referred to art. 15, 16, 17, 18, 20 and 21 of the GDPR may be exercised. In particular:

- a) the right to access personal data;
- b) it's correction in case of inaccuracy;
- c) the deletion of data;

- d) the limitation of processing;
- e) the opposition of processing;
- f) the right of data portability: that is, to receive the personal data provided in structured format commonly used and legible by automatic device and to obtain its transfer at another Data Controller without impediments.

In case of violation of the present provisions, the interested party has the right to propose a complaint to the competent Control Authority (art. 77 of the GDPR).
